Days of yonder...

- DTI ENUM Workshop in 2001
- Led to formation of UK ENUM Group (UKEG)
 - Informal, representative industry body
 - No legal status or membership
 - Best efforts basis by volunteers
 - Open and Transparent



UKEG achievements...

- Defined roles, interfaces and responsibilities
 - Governance models, accreditation
- Successful trial in 2003
 - Trial report encouraged DTI to proceed toward commercial operation of ENUM
- Gave birth to UKEC



About...

- UKEC formed in October 2006
 - Non-Profit, Limited by Guarantee
 - 4 Interim Directors

- Recognised as the oversight/
governance body for ENUM in the UK
 - regulator (note lower case "r")

- Awarded Tier 1 Registry to Nominet



Structure...

- Member based model
 - OMOV
 - Belief in self regulation
 - Membership fees depend on turnover

- AGM - 25 March 2008
 - 4 Initial Directors elected
 - 12 members to start with



Post AGM...

- Transfer of responsibilities and knowledge
- Tier-1 Registry representative appointed to UKEC Board
- Interim Secretariat appointed
- Outreach started



How we operate...

- Weekly Board conference call
- Monthly Board meeting
- Monthly Joint Review Committee conference call or meeting
- Secretariat deals with the paperwork



Nominet's role...

- 5 Year Contract for Tier 1 Registry
 - Annual fee to UKEC
 - Proportion of registration fee to UKEC
- All UK ENUM Registration services
- Operate UK ENUM Nameservers
- Marketing and PR
